- 1. **Welcome by the chair.** The chair thanked all for attending.
- 2. **Apologies for absence.** Mike Halliwell (HDAA), Tony Harris (Eden Drive), David Ruffles (John Garne Way), Jonathan Clark (Trap Grounds), Andrew Faitweather-Tall (Barrack's Lane).
- 3. **Minutes of the 2015 AGM.** These were accepted as a true account of the meeting. There were no Matters Arising.
- 4. **Annual Report**. The chair asked for any questions on the report which had been circulated. There were no questions.
- 5. **Annual accounts and treasurers report.** JL summarized his report by reading the front cover page of the accounts documents. # a/Dates for the 201 ODFAA/OCC allotment competition

TT reported on changes to the competition rules.

- 1) Entries for the best kept section must submit a minimum of two individual plots from that site.
- 2) A new section for small plots (5 poles or less) will be introduced, applying the same judging criteria used for full size plots.
- 3) To compete for the Alderman Knight Shield for the best kept site at least two entrants must be put forward.

The final date for entering the competition will be, Wednesday 6<sup>th</sup> May. Judging will take place 22<sup>nd</sup> and 24<sup>th</sup> May, 4<sup>th</sup> and 5<sup>th</sup> September. Prize giving will be 27<sup>th</sup> September which is earlier than usual due to holiday commitments.

WSS asked for volunteers to help with the judging, warning that a lack of people willing to judge, could lead to the failure of the competition in the future. A member asked if a description of the duties for someone who might consider judging could be drawn up. TT said he would try to put something together.

## b/ Progress with allotment signs

WSS showed the meeting the latest version of the new sign. It had a smaller OCC logo and had a decent space to include the longest association name along with web site information. WWS went on to explain that if every site agreed to have the new sign, the cost would be in the region of £2,132.00. She proposed that ODFAA should contribute up to this amount. The meeting agreed to this.
